- c. Lots of confusion regarding the lawsuit. It is not about whether or not there will be an inland port. That will happen. It's about whether Salt Lake or the State will control the planning, governance and taxation of the proposed inland port area. Charlie explained the history and his position on the RDA funds for the portion of the inland port area under consideration in the City Council meeting this week. Salt Lake City wants to preserve about 3,000 acres for wetland, require LEED certification of buildings, include some solar power electrical generation, etc.
